**3. Other ATCO Gas and Pipelines Ltd. Charges**

In addition to the ATCO Gas and Pipelines Ltd. charges specifically identified in these Rate Schedules, Direct Energy Regulated Services' Rates G1, G3 and G5 will include, as applicable, all ATCO Gas and Pipelines Ltd. charges under Riders A, B, G, H and I, as well as any other charges or riders levied by ATCO Gas and Pipelines Ltd. and approved by the Alberta Energy and Utilities Board.
