In addition to the ATCO Electric Ltd. charges specifically identified in these Rate Schedules, Direct Energy Regulated Services' Rates E1, E2, E3, E4, E5, E6 and E7 will include, as applicable, all ATCO Electric Ltd. charges under Riders A-1, E, and J, as well as any Power Factor Corrections and Price Options, or other Charges or Riders levied by ATCO Electric Ltd. and approved by the Alberta Energy and Utilities Board.
